

Financial Aid Satisfactory Academic Progress (FA-SAP)

Student Financial Aid

Des Moines Area Community College (DMACC) has two standards for measuring academic progress:

1. The U.S. Department of Education has defined the academic standard measurements the Financial Aid Office must use when determining eligibility for financial aid. The policy must measure both grade point average (GPA) and credit hours earned. These standards apply to a student's entire academic record at Des Moines Area Community College whether or not financial aid was received for prior terms of enrollment.

General FA-SAP Requirements

Federal regulations require that students maintain Satisfactory Academic Progress (SAP) in order to receive financial aid. The College's records are reviewed at the completion of every semester of enrollment (Fall, Spring, Summer) to determine compliance with the SAP policy. *Federal regulations require that this SAP review be completed for all periods of enrollment, regardless of whether or not aid was received.*

There are three components to the financial aid SAP policy:

1. **Minimum GPA** – Students must maintain a cumulative GPA of 2.0 or higher to remain eligible for financial aid.
2. **Minimum Pace of Completion** – Students must complete coursework at a minimum cumulative rate of 67%. (Credits earned / credits attempted = Pace of Completion). Credits earned include any credits for which a student receives a passing grade along with transfer credits. Credits attempted include passed credits, failed courses, course incompletes, withdrawals, repeats, audited courses, test-out courses, and transfer credits. (Pace of Completion examples are provided on the next page.)

Financial aid Warning status occurs after a student's first term of not meeting one or both of the GPA and Pace of Completion requirements. Students on Warning status are still eligible for financial aid their next term of enrollment.

Financial aid Suspension occurs when a student receiving financial aid on Warning status fails to meet the GPA and Pace of Completion requirements following their next term of enrollment. Students on Suspension status are not eligible for financial aid.

3. **Maximum Time Frame** (Duration of Eligibility) – Federal regulations limit financial aid eligibility to 150% (for example, 96 credits for a two-year program) of the published length of the education program, as measured in attempted credit hours. Transfer credit hours (if available) are counted in the calculation of duration of eligibility.

When a student has attempted over 150% of the number of credits required for their program, they are placed on financial aid Suspension.

Appealing Financial Aid Suspensions

Students who have extenuating circumstances may appeal their financial aid suspension.

Pace of Completion Examples:

Cumulative 2.0 GPA is assumed for all examples.

Pace = Cumulative credits earned \div Cumulative credits attempted

Example 1 - Natalie - First Year Student

Example 2 - Sarah - First Year Student

Hours Attempted	12	12	24
Pace of Completion	50%	67%	58%
Financial Aid Status after Semester	Warning	Suspension	Not Eligible (needed 67%)

*Student met 67% requirement for the semester, but did not meet the cumulative 67% pace required for financial aid.
