## **Boone Campus Student Activity Center**

The \$6.5-million Student Activity Center addition is financed in part by more than \$800,000 in private gifts to the DMACC Foundation. The centerpiece of the addition is the Fareway Fieldhouse, which includes two college-size basketball/volleyball courts, and three 40-foot by 70-foot batting cages that drop down from the ceiling. Additionally, the facility offers a state-of-the-art weight room, a contemporary sports medicine lab, an indoor golf performance center, storage space, office suites and a family room.

# Boone Campus Addition Nears Completion

As summer gives way to fall on the DMACC Boone Campus, the new Student Activity Center is coming to life. Great weather conditions from the groundbreaking in April right through September helped the construction crew keep the project on track for an opening during the Fall Semester.

In addition to providing enhanced space for recreation and sports, this project will also allow DMACC to host community basketball and volleyball tournaments, youth camps and more.

“The new Activity Center expands our ability to provide space and time for student wellness activities,” says Boone Campus Provost Dr. Andrew Nelson. “The new space will also give our athletic programs the ability to stay on campus year-round for practice and training, plus give additional space for competition.”

## New Era for Students, Athletes

All DMACC athletics are located at the DMACC Boone Campus, including men's and women's basketball, men's and women's golf, men's and women's cross country, men's baseball, women's softball and women's volleyball.

“The new facility will be a great new addition for us as students and athletes. We will have a place to go and be active anytime of the year,” says DMACC baseball player Dylan Voves. “It will enhance practices for our team as it eliminates having to travel off campus for practice during the winter months or when we can't be outside due to rain. Everything we need to get better each day will now be right on campus for us, which will definitely benefit our development as students and athletes.”

## *Fareway Donates \$250,000 to DMACC's New Boone Campus Student Activity Center*

Fareway Stores, Inc., headquartered in Boone, provided a \$250,000 lead gift for the new DMACC Boone Campus Student Activity Center.

Fareway will be the sole and exclusive sponsor of the new competition gym and multipurpose area within the facility, which is named the "Fareway Fieldhouse."

"We are proud to partner with DMACC on their Boone Campus Student Activity Center," says Fareway President and CEO Reynolds W. Cramer. "Not only will the Center help add to the high-quality experience available at the DMACC Boone Campus, it is a public-private commitment to support the overall well-being of the Boone community."

Fareway and DMACC are also working out the details to hold a Fareway Night each fall or spring in the new facility for Fareway employees to attend an athletic event.

DMACC Director of Athletics BJ McGinn said the new facility adds more than 28,500 square feet to the existing gym.

"The current facilities on the Boone Campus are dated,

overcrowded and do not accommodate the current needs of the students," McGinn said. "DMACC's athletic teams practice off-site during much of the year, and when the facility is used by the student-athletes it limits the availability for our student population."

DMACC President Rob Denson says Fareway's gift helped bring the vision for the addition to reality. He adds that Fareway has been a longtime supporter of DMACC and particularly of the DMACC Boone Campus.

"I look forward to seeing Fareway's logo prominently displayed in the new gym and multipurpose area and on the exterior of the building," Denson says. "We want to thank DLR Architects, Construction Manager Baxter Construction and all of our contractors for their great work on this important project."

# Greiner Gift Gives Boost to Campus, Community

As long-time residents of Boone, it was an easy decision for Fred and Laurie Greiner to support the expanded and updated Student Activity Center on DMACC Boone Campus. The couple considered the vision for the nearly 30,000-square-foot addition—to provide a vastly enhanced recreation and athletics experience for students and the community—a big win for campus and for Boone.

“When you look at it as an addition to the Boone Campus, it is huge,” Fred says. “When students and athletes are considering a college, it is important to have updated facilities. This is a big upgrade in that respect and will serve as a wonderful recruiting tool for students and athletes alike.”

“It is also a great thing for Boone,” Fred continues. “This will attract people to Boone where they will spend some time and money. It has the potential to take Boone to another level.”

Fred and Laurie have been long-time supporters of DMACC Boone Campus. Their son played basketball for the Bears in

the late 1990s and, more recently, Fred has served as a DMACC Trustee, and a member of the DMACC Foundation Boone Committee.

“This is clearly something we need on our Boone Campus,” Fred says. “Compared to the other schools in our conference and community colleges in the state, we haven’t been up to their level.

This will instantly move us up to the top level of community college athletic facilities in Iowa.”

An added bonus for Fred is that the new competition gym will carry the name of his long-time employer. The former President and COO of Fareway, he was proud when the company made the lead gift.

“I’m in a really unique position,” Fred says. “Working for Fareway and being in this community, I always felt it was important to give back. And as I became more involved at DMACC,

it just enhanced my appreciation for both organizations. I’m a big believer in Fareway and DMACC and I am so pleased the two were able to come together. The addition of the Fareway Fieldhouse is magnificent.”

Sally, who has lived in Boone since 1959 and served the Foundation Boone Committee for nearly two decades, was among the first to make a gift in support of the new Boone Campus Student Activity Center.

“We attract very good students and very good athletes to our Boone Campus,” Sally says. “This project will just serve to continue that.”

She says catering to students who are seeking recreational and athletic outlets like those offered in the Student Activity Center also benefits the community of Boone as a whole.

There is also a personal connection for Sally. Her late husband, Lloyd, was an attorney and instrumental in the establishment of the Boone Campus Foundation, one of the first campus foundations at DMACC in 1971. In addition, one of her three sons graduated from Boone Campus and recently returned to give a commencement speech. Sally says she is excited to carry on her family’s support of DMACC and of the greater Boone community.

“This is something for Boone to be proud of,” she says. “When you bring in students and athletes, you also bring in the parents. And when you have strong athletic programs you bring in fans. All of that has a financial impact on the community of Boone. That is a wonderful thing.”

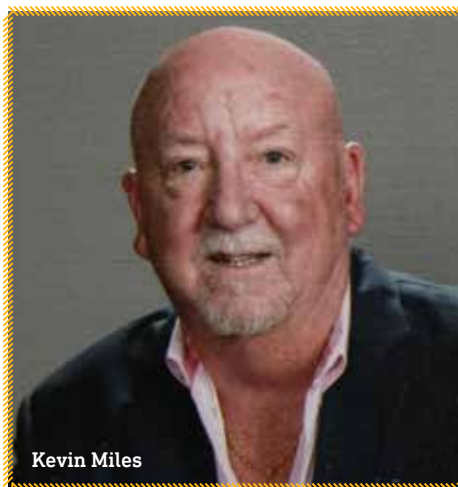
# Legacy Gift Honors Miles

Melissa said it was fitting to join Lisa, Erik and the family in

making a gift.

“The fact that we can help bring to fruition all of the hard work that Kevin helped put into this really means a lot to our family,” Melissa says. “He was such a big supporter of everything that DMACC had to offer our community. It will be a truly bittersweet moment when they cut the ribbon, and he is not there to see what all of his hours of work helped to bring to DMACC and the Boone community.”

Lisa says the memorial gift will result in Kevin’s name being associated with the DMACC basketball programs in the future. She adds that it is a fitting way to honor a man who loved the DMACC Bears.

“Kevin was so committed to the success of this project because of what it meant to the overall Boone Campus athletic and educational environment and what it would mean to the Boone community,” Lisa says. “It is meaningful to support a worthwhile project while giving back to a community that embraced me with open arms so many years ago when I began my professional career here.”

# It's Easier Than Ever to Support DMACC

## Make a Tax-Free Gift From Your IRA

You've worked hard, saved diligently and are ready to enjoy your retirement years. Maybe you're also looking for a way to give back to the organizations and causes that have been important to you. Consider making a gift from your IRA.

If you're 70½ or older, you can use the IRA charitable rollover to make a tax-free gift to the College. This law allows you to transfer any amount up to \$100,000 directly to a qualified charitable organization without paying income tax on the distribution.

When you use the IRA charitable rollover to make a gift to DMACC:

- Your gift will be put to use today, allowing you to see the difference you're making.
- You pay no income taxes on the gift. The transfer doesn't generate taxable income or a tax deduction, so you benefit even if you do not itemize your tax deductions.
- Required Minimum Distribution (RMD) guidelines for the year have been modified in response to the pandemic. We recommend you visit with your financial advisor or tax planner to discuss IRA charitable rollover gifts.

## Not 70½ Yet?

You can still support our mission with your IRA. Simply name Des Moines Area Community College as a beneficiary of your account, and we'll receive the funds, or the portion you designate, after your lifetime.

# Ways to Benefit From a Year-End Gift

The final months of the year are traditionally considered the season of giving. In addition to the gifts we give to the important people in our lives, this season of generosity is also the prime time to show support for the causes we love. When you support our organization this year, not only will others benefit, but so will you.

## Explore Your Options.

Although there may still be time to make several different types of charitable gifts, based on your unique situation and tax considerations, some gift types may be more practical than others.

The following options are popular among donors.

## Make an immediate impact.

Cash is an easy way to give each year. You can receive an income tax charitable deduction for the full value of the gift. If you write a check for less than \$250, a copy of the check will suffice as a record of the gift. You should obtain a receipt for gifts of \$250 or more.

## Save taxes on appreciated stock.

When you donate stocks to our organization that are worth more than what you originally paid for them, you can claim deductions for their full fair market value and eliminate any tax on the appreciation.

## Avoid the hassles and costs associated with selling real estate.

Like securities, if you try to sell appreciated property, you will be subject to capital gains tax on the appreciation. By donating the property to charity, you can enjoy tax savings and relieve yourself from the hassles of selling or maintaining it.

## Put an insurance policy to good use.

An old policy you no longer need can make a big impact on our work. To qualify as a deductible gift, our organization must become the policy owner. For most types of insurance policies, your tax deduction is usually the cost basis or the fair market value of the policy—whichever is less.

It is more common for policies to still require premiums to be paid. When you donate these, the future premiums are tax-deductible as you pay them.

## Repurpose special personal items.

Perhaps you have tangible items, such as artwork or other collectibles, that you would like to give to our organization to support our mission. Please contact us so that we can help you determine the charitable deductions for your personal property gift.
