

## NOTICE OF INTENT FOR GMP CONTRACT FOR CMaR

### Notification:

Des Moines Area Community College DMACC (Owner) intends to enter a Guaranteed Maximum Price (GMP) contract for the construction of a new Diesel/Trades building project, including Diesel Technology, HVAC, Building Trades, and Fire Science programs, to be located on the DMACC Ankeny Campus 2006 S Ankeny Blvd, Ankeny, IA 50023. The project is planned for completion in 2026.

The Owner will be publishing a request for statements of qualifications (“RFQ”) for Construction Manager at Risk (“CMaR”) services for the project on December 2, 2024. The CMaR will be engaged using a two-step solicitation process. A CMaR with sufficient qualifications based on the following selection criteria will be offered the opportunity to submit a Request for Proposal (RFP) to serve as CMaR for the project:

- General Information (minimum requirements documentation)
- Relevant Project Experience, Qualifications, & Past Performance
- References
- Project Team and Company Structure
- Local Market Experience and Iowa Preference
- Project Understanding and Approach
- Project Management & Approach
- Safety Record, EMR, & Internal Safety Program
- Financial Stability

At the proposal stage, qualified respondents will be asked to submit their proposed fees for the project. The Owner will select the CMaR that submits a proposal offering the best value based on the published selection criteria and on its ranking evaluation at the conclusion of the solicitation process.
